REGULAR MEETING:

1. Call to Order and Roll Call:

Brown called the meeting to order at 8:02 am. Present: Chairman, Malea Brown; Treasurer, Tracy Fletcher; Member at Large, Dan Johnson; and Vice Chair, Robert Southard. Member at Large, Jackie Gonzales arrived at 8:10 am

2. Approval of Minutes:

Tracy Fletcher requested that her name be corrected on the minutes from July 13, 2022 and October 19, 2022. Fletcher motioned to approve the minutes and Southard seconded the motion. The motion was put to vote. The motion passed.

4. 2022 Audit Engagement Letter

7. Fee Schedule:

Discussion of changes to the fee schedule were tabled so the document could be put on the web site for public comment.

8. Director's Report:

- The airports aircraft de-icing truck and the airpot is able to offer this service to the public.
- Concerns presented that Enterprise Rental car not fulfilling their contractual obligations. She is working with the board attorney and Enterprise for resolution.
- Travis Fasnacht has recently passed his DEQ certification . This certification will allow to airport to have a Class A certified inspector on the field .
- The airport is filing a claim for damage to two vehicles due to an employee accident.
- The airport will be bringing all janitorial services in house and cancelling the contract with High Plains Janitorial.
- The airport will have a float in the Christmas parade on December 2, 2022 to increase positive visibility in the community.
- Santa will be flying in on December 10th for community engadgement.
